JOB DESCRIPTION: ULTRASOUND TECHNICIAN

I. REPORTING RELATIONSHIPS

Reports to Clinical Director and Administrator.

II. INTERNAL RELATIONSHIPS

Communicates with Patients, Families, Clinical Office, Nursing Staff, Advanced Practice Providers and Physicians.

III. MAJOR DUTIES/RESPONSIBILITIES

Provide clinical and technical support with diagnostic medical ultrasonography. In addition, assists in the areas of policy/procedures and performance improvement. Must follow rules of patient confidentiality and HIPAA regulations.

IV. ESSENTIAL DUTIES AND RESPONSIBILITIES

Regular and punctual attendance.

Perform diagnostic radiography and medical ultrasonography in clinical setting.

Perform daily quality assurance and trouble shooting duties.

Develop and maintain quality assurance protocol to assess performance, outcomes, and utilization of service.

Assists in the areas of regulatory compliance/standards.

Maintain continuing education requirements as required.
Adheres to the attendance policies per specific department.
